You have probably heard the KHV been spoken about many times at branch meetings or in the news. So you may or may not be aware, the NSW government is looking at releasing Koi Herpes Virus (KHV) into Australian waterways to attempt to eradicate wild carp.

Australia is currently KHV-free and we hope to keep it that way, as the virus is fatal to our pet koi. We are ensuring that we stay involved in the process so that we can object at every opportunity.

Part of NSW's planning process involves finding out the financial impact that the virus will have on the Australian koi and pond industry and hobby. They have employed an accounting firm in Brisbane named Ridge Partners to conduct this confidential survey.

Please pass this link on to anyone else you may know that would be affected and get as many people as you know to complete the survey. We plan to have a paper version at the next branch meeting if you would prefer this option.

We have questioned if it is in our campaign's best interests to push this survey out, as we are not keen on doing anything which helps the NSW government progress their work, however if they don't get any responses to this survey, they will have no choice but to estimate the financial impact of losses and would like underestimate that impact.

Dear Members,

Our Annual Show is fast approaching on Sunday 28 May 2017. I'm looking forward to serving as the Show Chairperson again this year, and hope to see you all at the event.

- * Online entries are now open on the website (direct link available on our homepage www.koiclubwa.com).
- * If you don't have a computer, you can bring 1 photo of each fish to any meeting with class/variety/size written on the back, and I will scan and enter them.
- * The logistics are unchanged from last year: our location in the beautiful gardens at Willowpond; the water which will come from the same water truck source as previous years; and our hard-working team (Des as Chief Steward, Brett H as Logistics and Kevin as Sponsorship/Advertising) as well as the entire committee who help out.
- * The only rule change is that members can now enter 3 fish per variety per class instead of 2 previously.
- * The latest copy of the Show Entry Pack has been added to the website (on the Forms page or there is a link straight from the homepage)
- * Confirmed judges are: Tan Lee King - assistant certified - Singapore - head judge Wilhelm Geldenhuys - local certified - South Africa Lee Nguyen - local certified - Sydney, AU
- * First time Exhibitors pay no Show entry fees as always. We are here to help whether it's which variety to enter a fish in, or advice on transporting your fish to the Show. Call me anytime on 0428746620, email info@koiclubwa.com, or come along to any meeting.
- * Show entry fees are the same as before: Junior Exhibitor free, Table Show/Young Champion free, all other classes are \$10 per fish capped at \$100 max.
- * Members wanting to sell fish details are the same as last year: 5+ fish in the Show, \$80 per bin (max 2 bins) and the cost includes water (from same trucks as Show water), air pump and main line. Members to provide their own bin/s, airstones, airline/fittings, bags and oxygen.
- * Presentation dinner will be at Willowpond on the Monday night, further details will be in the next newsletter.

Koi Term Glossary

Here are some more terms used, these ones are to do with describing your koi.

Inazuma — (EE nah ZOO mah) Lighting-stripe pattern (zig-zag).

Aragoke - (ah rah GO keh) Large armour scales.

Kinitsusei – (KEE neet SOO say) Uniformity of color.

Tejima – (teh GEE mah) Sumi stripes in the fins.

Tezumi - (teh ZOO mee) Another term for sumi stripes in the fins.

Kindai - (keen DYE) Modern

Aigoromo – (eye go ROW mow) A Goromo (Koromo) koi with blue or indigo reticulation. Basically a Kohaku whose red scales have blue semicircular borders, giving the koi a reticulated pattern.

Kamisori – (kah MEE soh ree) Razor border, pattern that cuts across the scale.

Hana Shusui – (hah NAH SHOO swee) A form of Shusui, also known as a flowery Shusui with round red markings on the sides (between the back scales and the lateral line) instead of parallel the 'line patches' down the sides or regular Shusui.

Nezu - (NEH zoo) Gray color

Sashikomi – SAH shee KOH mee) Scales covering the front edge of the pattern.

Godan Kohaku – (GOH dahn koh HAH koo) A white koi with a five step hi pattern.

Matsuba - (maht SOO bah) 'Pine-Cone' scale pattern; single color koi (metallic or non-metallic) with scale reticulation.

Shirogoi - (SHEE roh goy) White koi.

Shiroji - (shee ROH gee) White area.

Zukinkaburi - (zoo KEEN kah boo ree) Red forehead.

Date: April 26, 2017 **Attendance**: 23 **Apologies**:

Meeting opened at 7.40pm. Fred welcomed everyone particularly Jason and Vineseen Soobbahrajoo (first time to the meeting), Julie and Keith, and life member Bill Passey.

Branch Treasurer Report: \$2553.20

National Carp Survey: Jun gave a quick update and informed members to keep an eye out for details in the newsletter. Visit www.carp.gov.au and if you have trouble completing the survey, contact Jun and he can help.

General Business

Tim informed the branch, that he hasn't been receiving his newsletter. Jun said it will be looked into and to please contact Ryan Witney (newsletter editor) editor@koiclubwa.com if you change your contact details.

Bill Passey put forward the motion that the Southern Branch should look at a new location for meetings with the time and dates to remain the same. It was noted, that the current Rotary Hall has served us for the last 20+ year. However, we are unsure how long we have access to the venue due to the construction of the new Community Hall. Joise and Miki suggested Willetton Pavilion as an alternatively; straight off the freeway and an opportunity to attract new members in the suburbs. Fred said it's a great idea and it could help us enhance and grow the branch. Nick Linton seconded the motion before it was put to the vote. The result was unanimous for the change. Jun as Southern Branch Secretary will look into it and will ensure enough notification for members and receive feedback.

Rodney suggested in the past that we had a combined meeting in May with the Northern Branch as the fourth Wednesday of the month is very close to the Koi Show. Members said it didn't bother them and they would like a meeting in May.

Shona gave a quick rundown of the show, with entries closing on Friday 19th of May. All information can be found in the show information Pack. You can pay your fee on the show day. The presentation dinner will be similar to last year, at \$45 a head.

Fred asked, how everyone is going with koi show preparations and asked who planned to show? Tony Herbert commented that he wasn't planning to show for the first time last year but was convinced to entry; and as a result had a wonderful time. He recommended that we should all give it a go and support the club. Fred also asked if anyone used aloe vera juice to reduce the stress of transporting koi?

Tony asked 'how long Virkon S stayed active for in water?' Allan suggested it would typically stay active for 2 days in the pond environment.

Jason asked how many fish should be in a 7,000litre pond. Bill shared his wisdom, noting that there are a number of factors. However, water quality and filtration are key when keeping a heavily stocked koi pond healthy.

Following the break, Jun made a presentation on the Nitrogen Cycle with a focus on Nitrate. Despite Nitrate being less toxic than Ammonia and Nitrite; in high concentrations it can have negative (but not fatal) effects on koi health/ growth. Jun shared his thoughts on how Nitrates can be reduces from koi ponds beyond extensive water changes and large surface area of plants filtration.

Typical of Ryan he had 3 searching questions

Q1. What do you consider the correct quarantine procedure to be and do you employ it?

A1. Having a separate pond with its own filter system to put new fish in. Some say to salt the water up to 3ppm and leave them in there anywhere from 6 weeks to 3 months and observe for anything that could be a problem. This is the KSWA position on quarantining. It is appreciated this is not always possible for everyone options are:- very careful look at the fish including underbelly and mouth., you can dip in salt bath when you get the fish home. Never buy/accept a fish which has any sores, however small or discolouration on the body.

Q2. In your experience do you believe that koi growth is limited by the size of pond / volume of water or is it in their genetics?

A2. Most people have seen large koi in small ponds suggesting that as long as the fish is healthy it will grow to its predetermined 'genetic' size, albeit slower than had it been given the space of a large pond. The key is never overcrowd. Feed the best food you can possible buy and keep your filters clean

Q3a. Do you feed your koi anything other than pellets regularly? A3a. Rice, Brown Bread, Oranges, Watermelon

Q3b. Do you change your feeding in preparation for showing?

A3b. Melbourne Cup winners don't get feed on bread! It is no different for preparing fish for a Show. Generally speaking you can 'condition' fish for a show. Titbits like oranges, bread and honey, higher grade of food all leading up to the show will assist

Jun had a presentation on the All Japan Show he attended in Feb and showed some slides of the trip and koi from the Show. This was a great presentation and for those that had a limited concept of the size of the top Japanese fish it was WOW. Yip they are huge. Well done Jun.

Tea break and Fred and Barry judged the table show. Thanks guys sorry to call on you yet again Because we are getting a lot of fish on the TS, agreed that even those hobbyists with fish in the TS would be called upon to judge.
